 - Supporting their international mobility.
 - Looking for alternative sources of funding (participation in programs, sponsorships, donations, etc.)

- Ensures the connection between teaching and research.
- It is informed about the level of professional rehabilitation of its graduates and disseminates professional rehabilitation information to students beyond the standard.
- Based on the possibilities it has (teaching staff-logistical infrastructures) it ensures the appropriate annual number of admissions, so that it can offer high-quality education to students.
